1. TERMS AND DEFINITIONS

- 1.1 "The Constitution" shall stand for the constitution of the ARD Athletic Club.
- 1.2 "The WPA" shall stand for Western Province Athletics.
- 1.3 "The ASA" shall mean Athletics South Africa.
- 1.4 "The Chairman", "The Secretary" and "The Treasurer" shall mean the officials as specified by the ARD Athletic Club.

2. NAME OF CLUB

- 2.1 The club shall be called the **A.R.D. ATHLETIC CLUB** and shall be composed of members elected in accordance with the articles of this constitution.

3. HEADQUARTERS AND ADDRESS OF CLUB

- 3.1 The headquarters of the club shall be Grassy Park.
- 3.2 The postal address of the club shall be P.O. Box 446 Woodstock 7915.

4. OBJECTIVES OF CLUB

- 4.1 The objectives of the club are :
 - 4.1.1 To encourage the sport of road running, road walking, cross-country running and track and field.
 - 4.1.2 To encourage athletics in general by arranging competitions and sports meetings and road races.
 - 4.1.3 To promote a healthier lifestyle through sport.

5. WAYS AND MEANS OF ACHIEVING AIMS AND OBJECTIVES

- 5.1 By affiliating itself to the WPA.
- 5.2 By providing facilities, equipment and other conveniences necessary for the practicing and carrying out of the sport of Amateur Athletics.
- 5.3 By acquiring property legally, both movable and immovable, as may be required to achieve the aims and objectives of the club.

6. CLUB COLOURS

- 6.1 The colours of the club shall be RED WHITE and ROYAL BLUE.
 - 6.1.1 Vest will be white with red.
 - 6.1.2 On the front and back will be the A.R.D. emblem.
 - 6.1.3 Royal blue shorts and pants
 - 6.1.4 Club gear to be purchased via the Club only.

7. ANNUAL SUBSCRIPTIONS

- 7.1 Subscriptions shall become due upon renewal of membership or upon joining the Club for new members.
- 7.2 The members shall determine the annual subscriptions at the AGM.
- 7.3 Juniors shall pay only the Licence fee as charged by the WPA.

8. APPLICATION FOR MEMBERSHIP

- 8.1 Anyone applying for membership shall complete and sign the club's official application form.
- 8.2 Members acquiring Licences shall complete and sign the WPA registration form.
- 8.3 Membership is open to all provided they are in good standing.

9. VOLUNTARY TERMINATION OF MEMBERSHIP

- 9.1 Members desirous of resigning shall do so in writing.
- 9.2 The committee shall reserve the right to withhold the granting of clearance certificates to any member tendering his/her resignation until such a member has met all his/her financial obligations to the club.
